

Official Rules for the Badlands Off Road Travel Package Grand Prize Promotion!

Grand Prize provided by Badlands Off Road Park

1. Duration of contest. The contest runs from Friday, February 16th, 2018 through 4 pm, Sunday, February 25, 2018

2. Eligibility. All persons must be at least 18 years of age to be eligible to enter. Limit of one entry one person.

3. How to enter. You may enter beginning Friday, February 16th, 2018 by visiting the show and completing the entry available at the Ford Indianapolis Boat, Sport & Travel Show from Friday, February 16th through 4pm Sunday, February 25, 2018.
